

NATIONAL TEAM REQUIREMENTS

Individuals interested in representing WSRBA as a member of the national judging team, breed ID team, or Quiz bowl team at the annual ARBA convention will need to participate in the competitions held at the annual Wisconsin State Convention.

For consideration for the national Judging team, each individual will judge and score 4 groups of rabbits or cavies using the ARBA judging score card at the state Convention competition the second weekend in September.

For consideration for the Breed ID teams, they will identify 25 rabbits or cavies including the Breed name, show room classification, registration classification, and 4 or 6 class animal. This will also take place at State Convention.

Each youth member will complete the application and mail it the national team advisor listed on the application. To receive full credit, the application must be postmarked by the appropriate date listed on the application.

Individuals are encouraged to participate in the educational opportunities at the shows throughout the year. They should make sure they sign in on the attendance sheet with the advisors at these activities. They will earn 5 points towards for each event they participate in.

A. Application must be postmarked by MAY 15, 2017.

B. Contests will begin at **10a.m. on the Saturday of the FOX VALLEY SPRING FLING SHOW JUNE 10, 2017.** All contestants must check in with youth Contest Volunteers by **9:45a.m.**

C. Contestants must be a member of the WSRBA and reside in the State of WI.

D. Contestants may not compete for another state or district team.

E. Please see the National Team pages in the WSRBA Constitution for more information on the Contest.

F. Must be able to attend the **ARBA National Convention in Indianapolis, IN this fall from September 30-October 5, 2017**

G. Upon making the National Team the Parent of the youth MUST NOTIFY National Team Chairs within one week after notification of making the team if they no longer are able to attend nationals.

H. ARBA Youth Contest will be held on **Sunday October 1st**. It is beneficial for kids to arrive the day before to become acclimated to area. A Team Meeting will take place **Saturday evening September 30th at 6pm**

I. Youth may not leave the test area without permission or they will forfeit their scores.

J. Youth must follow rules and direction of the Youth Committees and their volunteers

K. Any disobedience might disqualify youth from competition at the discretion of WSRBA Youth or National Teams Chairperson.
